APPLICATION & DEPOSITS

Application Fee

A one-off application fee of QAR 595 must accompany each application form. This non-refundable fee covers the administrative work involved in processing an application.

A non-refundable registration fee of QAR 4,163 must be received after a student has been accepted and before a place can be confirmed.

Towards the end of each academic year a non-refundable and non-transferable pre-registration deposit of OAR 5.946 will be payable at the time of pre-registration of existing students, to guarantee a place for the following academic year. This will be deducted from the first semester tuition fee invoice each year.

TUITION FEES

Tuition fees are paid per semester; there are two semesters per academic year. Fees include the loan of textbooks, laboratory fees, classroom materials, IT resources and curriculum-related field trips that take place within a single day.

High School fees (Grades 9-12) include technical infrastructure to enable students to bring their own laptops to school.

We respectfully advise that all fees for the academic year 2024-25 may be subject to change pending final approval of the Ministry of Education (MOE), this includes application, registration, annual capital charge and annual tuition fees.

Annual Capital Charge

A non-refundable annual capital charge of QAR 5,352 is payable in respect of the school's investment in, and maintenance of, educational facilities. This fee will be added to the first tuition fee invoice each year.

INVOICES

ACS Doha sends invoices two times a year (once per semester). These are sent electronically.

ADDITIONAL COSTS

Lost or Damaged Text Books

A set of text books is loaned to each student. At the end of the year, or earlier for transferring students, the books must be returned in the condition in which they were issued, allowance being made for fair wear and tear. A charge will be made for textbooks/library books lost or damaged beyond the accepted standard.

Extra-curricular Activities

We understand the value of extra-curricular activities in helping to provide a well-rounded and balanced school experience. Some activities are free of charge, other options incur an additional charge (ACS parents should direct any payment enquiries to the Finance Office).

Exam Fees

External exam fees are also in addition to the school fees with an expected cost of around QAR 4,200 for the full IB Diploma Programme and around QAR 3,500 for the IBCP. AP Standard fees are QAR 720 per exam (ACS reserves the right to amend these fees if examination bodies increase their charges).

Students in Grade 10 are registered for MYP eAssessments. Charges for these qualifications are determined according to the examining body's fees. For the May 2025 examination session, fees for the selected subjects are anticipated to be around QAR 3,000 in total (ACS reserves the right to amend these fees if examination bodies increase their charges).

Additional fees will be due for students re-taking any Grade 12 subject exam or requesting a re-mark of any exam papers.

University Applications

Application fees for universities are additional to school fees and vary depending on student options, according to country and university.
